Product Type & Application

Bradford Fireseal[®] Curtain Wall Batts are non-combustible, plain (unfaced) Rockwool insulation. This product is suitable for us as a fire barrier, retarding the progress of fire and heat between floors of multi-storey buildings.

Compliance with the New Zealand Building Code

When correctly specified and installed, this product meets or contributes to compliance with the following performance requirements of the building code:

- **B2 Durability** B2.3.1(a) rockwool insulation has a wellestablished history of use in service.
- C3 Fire affecting areas beyond the fire source C3.5, C3.7 - . Bradford Fireseal® Curtain Wall Batts is noncombustible and contributes to preventing fire spread between floors of multi-storey buildings.
- F2 Hazardous building materials F2.3.1 Bradford Fireseal[®] Curtain Wall Batts do not emit or give rise to harmful concentrations of gas, liquid, radiation or solid particles.

Limitations of Use

- **IMPORTANT:** Do Not Modify This Product: Compliance with the evidence of suitability data referenced in this document is only achieved by the product or configuration listed in this PTS.
- This product is not suitable for use as an exposed wall or ceiling lining in applications which require a Group Number in accordance with C3.4(a)
- Unfaced Rockwool is not a water or vapour barrier and is not suitable for water or vapour control.
- AS/NZS 1530.4 assessment FAS190138 by Warringtonfire demonstrates the anticipated non-structural FRL in the systems nominated in the assessment. The suitability of this product for the specific system requirements in an application must be confirmed by the relevant project certifier, fire engineer or other principal certification authority.

Conditions of Storage, Use & Maintenance

 Store in the original packaging in a cool, dry area, away from foodstuffs. Ensure packages are adequately labelled, protected from physical damage, and sealed when not in use. Avoid packaging being stored under UV light (direct sunlight) for long periods.

Specific Design or Installation Instructions

- Isolate power before installation.
- Caution: Electrical cables and equipment partially or completely surrounded with bulk thermal insulation may overheat and fail. In new build construction with electrical wiring in accordance with AS/NZS 3000:2018 or later, wiring may be partially or completely surrounded for up to 400mm. If more than 400mm is surrounded, or for wiring pre AS/NZS 3000:2018, seek advice from a licenced electrician. Refer to legislation and referenced standards for full details or seek advice from an electrician if in doubt.
- The product is designed to be installed between the edge of the concrete floor slab and a fire rated spandrel panel to provide floor to floor fire separation in multi-storey buildings.
- Fireseal® Curtain Wall Batts must be installed with at least 10% compression in the vertical opening between the edge of the concrete floor slab and a fire rated spandrel panel parallel opening gap dimension to be in the range of 10mm to 150mm
- Fireseal[®] Curtain Wall Batts must be abutted to neighbouring/adjacent batts to provide a compressed fit into the joint.
- The Fireseal[®] Curtain Wall Batt will match the FRL of the fire rated spandrel panel of up to a maximum of 120 minutes.
- Installation guidance: Pre-compression of batts may be achieved out of position by compressing the batts between thin metal slip sheets and then inserting product into position before removing the metal slip sheets.
- Suitable for applications that specify non-combustible bulk insulation products not suitable for exposed internal wall and ceiling lining applications that require a Group Number.
- Insulation should be installed so that it forms a continuous layer and abuts or overlaps adjoining insulation other than at supporting members such as columns, studs, noggings, joists, furring channels and the like where the insulation must butt against the member.
- Suitable for applications where the product is protected from UV light, water and wind pressure during and after installation.



Applicable Installed Thickness



Application variations:

- The supporting floor construction varied from Hebel[®] to solid masonry or concrete of density varying from 737kg/m³ to 2400kg/m³ or otherwise tested by others to achieve the required FRL of the seal.
- The gap opening shall be at specific values in the range of 10mm to 150mm and the compression of the CSR Bradford Fireseal® Curtain Wall Batt shall be as tested or marginally increased.
- The depth of floor slab shall vary from 120mm or greater, so the supporting floor slab's FRL is no less than that of Fireseal[®] Curtain Wall Batt FRL performance expressed in the Applicable Installed Thickness table above.
- CSR Bradford Fireseal[®] Curtain Wall Batt FRL performance expressed in the Applicable Installed Thickness table above shall be further limited by the FRL performance of the abutting material, such as the FRL of a wall element made from masonry, AAC Hebel, Spandrel wall system, or curtain wall system.
